The Tsarlack Constitution

The Tsarlack Constitution for the Fourwall Kingdom of Tsarlack legitimates the formation of the State of Tsarlack / Kingdom of Tsarlack that will be the de jure and de facto rule on the Tsarlack islands. The State of Tsarlack by signing the Fourwall Tsarlack Treaty will adopt the Tsarlack Constitution and mandate the Tsarlack Government to form an administration to govern the affairs of the Tsarlack islands. For this constitution to officially come into force it must first be endorsed via a referendum by the people of Tsarlack.

The Tsarlack Union of the Tsarlack Government and the Down Tsarlack government seize to exist and all institutions of both governments will be amalgamated into the State of Tsarlack.

The Tsarlack constitution recognizes the authority of the following Tsarlack entities:

The Tsarlack Royal Act of 1978 is adopted into Tsarlack Law No.1325B

As stated on the revised Tsarlack Royal Act No.1325B, the Tsarlack Royalty's role within the State of Tsarlack is to bestow Tsarlianism on all the islands of Tsarlack. This constitution grants the Tsarlack Royalty full restoration to the throne and crown of the Kingdom of Tsarlack. Conditions of any form of Royal Tsarlack abdication are hereafter on deemed unconstitutional. The Tsarlack Royalty may veto towards the Stare of Tsarlack institutions.

The official constitutional title of the kingdom is "Quattuormoenia Regnum Tsarlacktanum" as stated in Latin and "Τετράτοιχο Βασίλειον Τσάρλακος" as stated in Greek. In Tsarliotic English is translated as "Fourwall Kingdom of Tsarlack". The Tsarlack Royalty reign may be simply referred to as "Kingdom of Tsarlack".

The City of Tsarlack is an autonomous mayoralty. The constitution grants a single lifetime Mayor of All Tsarlack the right to be the chief Tsarlack magistrate. The Mayor of All Tsarlack appoints a deputy that bares the title "Vice Mayor of All Tsarlack" to assist in the city's affairs. The constitution gives executive power to the City of Tsarlack in Tsarlack politics and Tsarlack life. The City of Tsarlack may veto towards the Stare of Tsarlack institutions.

The Church of Tsarlack (COT) is recognized by the Tsarlack Constitution to be the main religious organization in the Tsarlack islands. It is an autocephalous eastern Tsarlack-Rite Christian church. The COT canon law is recognized by the Tsarlack Constitution. The COT canon grants a single lifetime Archbishop of Tsarlack the right to be the head of the Church of Tsarlack.

d) Executive System:

The State of Tsarlack is administered by the Tsarlack Government.



Tsarlack Government:

For the administration of the Tsarlack Government the constitution grants The State Council of Tsarlack the right to govern. The State Council of Tsarlack has 7 members elected by the people of Tsarlack for a 3 year term. The State Council of Tsarlack answers to the head of state chain of command whereby is as follows:

- 1. King of Tsarlack Head of the Kingdom of Tsarlack
- 2. Mayor of All Tsarlack Head of the City of Tsarlack
- 3. Prince of Andi Head of the Principality of Andi
- 4. Archbishop of Tsarlack Head of the Church of Tsarlack
- 5. Vice Mayor of All Tsarlack Second in command of the City of Tsarlack

The Tsarlack Government Cabinet consists of persons appointed by the State Council of Tsarlack, to head the Tsarlack Government ministries and other executive departments, agencies and bureaus. It is responsible for the day-to-day administration of the State of Tsarlack as well as for its economic regeneration.

The head of the Tsarlack Government Cabinet is the Tsarlack Prime Minister that answers directly to the State council of Tsarlack. The Tsarlack Prime Minister is appointed with a no fixed term limit.

The King of Tsarlack is represented in the Tsarlack Government by the "High Representative of the Tsarlack King to the Tsarlack Government" who is also the director of the Department of Royal Tsarlack Affairs.

Local Cities/Counties Governments:

Each of the Cities and Counties that are under the sovereignty of the State of Tsarlack are administered by a local authority headed by a Mayor/Count, elected by the resident Tsarlack and EU citizens. The Mayor/Count heads the Local City Council along with other 7 members to head the executive departments of the City/County and to act as official advisers to the Mayor/Count. The State of Tsarlack laws surpass local laws.

e) Legislative System:

The Tsarlack constitution provides a bicameral style legislature of two houses. The process to legislate the Tsarlack State is as follows:

The Tsarlack Parliament

The Tsarlack Parliament is the Tsarlack lower house and is elected by the Tsarlack Citizens. It is the originator of legislation bills. Elected parliamentarians bring foreword bills for discussion in fixed scheduled televised sessions. After extensive discussion parliamentarians put the proposed bill into vote and if absolute majority is achieved the bill passes to the Tsarlack Senate.

The Tsarlack parliamentarians are called "Members of the Tsarlack Parliament (MTsPs)". The leader of the Tsarlack Parliament is called "The Speaker of the Tsarlack Parliament".

The Tsarlack Parliament is composed of 324 elected MTsPs each representing at least one Tsarlack constituency according to population. MTsPs are elected to serve a period of 4 years. Eligibility to become an MTsP is open to all Tsarlack and EU citizens who are at least 21 and permanently reside on the Tsarlack Islands.

The Tsarlack Senate

The Tsarlack Senate is the Tsarlack upper house and is appointed by a special mechanism from the Tsarlack Parliament as well as special appointments by the Tsarlack Government's Department of Senator Appointments and the University of Tsarlack's Institute of Tsarlianism. The Tsarlack Senate reexamines, reconsiders, reassesses, re-evaluates and in a final process decides whether to veto or approve the bills. The Tsarlack Senate regularly meets in fixed scheduled televised sessions. If bills are approved are passed into Tsarlack Law enforceable by the Ts.P.D.

Members of the Tsarlack Senate are called "Tsarlack Senators". The leader of the Tsarlack Senate is called "The Honorable Tsarlack Senex". The Tsarlack Senate is composed of 50 Tsarlack Senators. They are appointed to serve a minimum period of 5 years.

f) Judicial System:

Tsarlack Law is based according to the laws of Tsarlianism with modified elements of common law, English common law and Roman civil law.

Tsarlack Supreme Court of Justice

The Tsarlack Supreme Court of Justice consists of the Supreme Tsarlack Judge and 12 associate justices [13 in Total]. At its discretion, and within certain guidelines established by the State of Tsarlack, the Tsarlack Supreme Court of Justice each month hears a limited number of the cases it is asked to decide. Those cases may either begin in the Tsarlack State Court or the Tsarlack Districts Courts, and they usually involve important questions about the Tsarlack Constitution or Tsarlack law. The Judges for this court are appointed in coordination by the State Council of Tsarlack on the advice of the King of Tsarlack and the Mayor of All Tsarlack. This Court is housed in the Tsarlack Supreme Court of Justice courthouse in PN, Montetsarlo.

Tsarlack State Court

The Tsarlack State Court has independent jurisdiction over disputes which have a connection to the Tsarlack Government. Cases are heard before and evidence is presented in a trial court. The Judges for this court are appointed by the State Council of Tsarlack on the advice of the King of Tsarlack and the Mayor of All Tsarlack. This Court is housed in the Tsarlack State Court courthouse in Court Hill, Weldomassa.

Tsarlack Districts Courts

The Tsarlack Districts Courts are the 6 trial courts of the 66 regions, territories and islands that are under the jurisdiction of the State of Tsarlack. Within limits set by the State of Tsarlack and the Tsarlack Constitution, the Tsarlack Districts Courts have jurisdiction to hear nearly all categories of cases, including both civil and criminal matters. The Judges for these courts are mainly appointed by vote from the Mayors and Counts of each of the six district territories.

h)Official Languages:

State Lingua Franca: Tsarliotic English

All official State of Tsarlack documentations are printed in 8 languages: Tsarliotic English, Français, Italiano, Español, العربية, Deutsch, Nederlands, Português. Tsarlack Passports & other travel documentations are all issued in English.

i) Ethnicity & Citizenship:

All Tsarlack Citizens are considered by the State of Tsarlack to be Tsarlian. The constitution does not recognize ethnic minorities. The State of Tsarlack does not discriminate on human race, language, religion and any kind of orientation except individuals who committed crimes against Tsarlianism. The Tsarlack constitution guarantees anti-discrimination and equal opportunities for all Tsarlack Citizens. All civic statistics are based on Tsarlack citizen's first language.

j) Currency & Taxation:

The Tsarlack Constitution establishes the Ts€ as legal tender on the islands of Tsarlack.

The Tsarlack Constitution recognizes the authority of The Central Bank of Tsarlack as responsible for the monetary policy of the State of Tsarlack. The CBTs primary responsibility is to maintain the stability of the Tsarlack national currency, the Ts€, and money supply.

In the prospect of a potential exit of Tsarlack from the Euro common currency the new Tsarlack currency unit should be the Tsarleon.

The Tsarlack Constitution gives the right to the State of Tsarlack to establish, regulate and collect taxes from its citizens for purposes of state funding. The established tax rate shall not exceed the level of 20%.

k) Security & Defense:

The State of Tsarlack commissions the Ts.P.D to keep order and security over its sovereignty. The State of Tsarlack is prohibited by this constitution to incorporate regular indigenous military forces.

n) Foreign policy:

The State of Tsarlack maintains its unilateral status and does not seek recognition by the established states of the world. The State of Tsarlack should remain neutral in all international matters.

Special Administrative Region of the European Union:

Tsarlack is a Special Administrative Region of the European Union. It fully complies with the law and regulations of the European Union. The EU acquis communautaire applies in all the sovereignty of the State of Tsarlack.

Representation in the European Union:

Special membership in the EU gives the State of Tsarlack an observer non-voting representation in all EU institutions. The State of Tsarlack has an observer seat in the Council of the European Union. Assigned representative is the Tsarlack EU Minister (TsEUM). The State of Tsarlack has an observer seat in the European Council. The assigned Tsarlack Representative in the European Council (TsREC) is the Tsarlack Prime Minister.

The Tsarlack European Parliament Constituency provides for 10 "Tsarlack Members in the European Parliament" as observers (TsMEOs) to represent 10 assigned observer seats in the European Parliament.

The State of Tsarlack sends a Tsarlack European Commissioner (TsEC) as an observer to the European Commission (in accord with The European Commission president).

The State of Tsarlack sends a Tsarlack European Judge (TsEJ) as an observer to the European Court of Justice and the European Court of Auditors (in accord with other member states of the EU)

The State of Tsarlack sends the government appointed governor of the Central Bank of Tsarlack as an observer to the European Central Bank (TsECB).

State of Tsarlack Diplomatic Missions:

The State of Tsarlack establishes diplomatic missions around the world to represent Tsarlack in foreign governments and international organizations. The Diplomat ambassadors or Consuls of the State of Tsarlack are referred to as "The Representative of Tsarlack" by the international diplomatic body. Similarly the foreign Diplomatic Missions in Tsarlack due to the unilateral status of the State of Tsarlack, foreign diplomatic missions in Tsarlack are not referred to as "Embassies" or "Consulates" but "Commissions", "Councils", "Diplomatic Representations", "Diplomatic Missions" etc..

o) Elections

By this constitution, The State of Tsarlack adopts voting by Tsarlack citizens who are requested to register and vote in public elections. The electorate consists of all Tsarlack and EU citizens over the age of 18 who permanently reside on the Tsarlack Islands. The elections are organized by the Department of Elections of the State of Tsarlack. Tsarlack Citizens voting rights are non-compulsory.

Tsarlack State Elections:

To elect the 7 members of the State Council of Tsarlack. Held every 3 Years.

Tsarlack Parliamentary Elections:

To elect the 324 MTsPs of the Tsarlack Parliament. Held every 4 Years.

Tsarlack Metropolitan Elections

To elect the Mayors and Counts of the 89 Cities and Counties of Tsarlack. Held every 5 Years.

Referendums

For consistent issues that come to a standstill within the Tsarlack Legislative System the people of Tsarlack must make a decision. Referendums if needed are organized every 6 years.

6. US Territories on Tsarlack:

The Tsarlack constitution recognizes the authority and sovereignty of the US over the Excadiz cities and counties. The EU acquis communautaire does not apply on the 23 US territories on Tsarlack. The Tsarlack Constitution expresses the need and desire for immediate Tsarlack Reunification!

Tsarlack **Right Conservatives** that tend to favor economic freedom, but frequently support laws to restrict personal behavior that violates traditional values. They oppose excessive government control of business, while endorsing government action to defend morality and the traditional family structure. The RiP usually supports a strong police force, oppose bureaucracy and high taxes and favor a free-market economy.



Royal Resilient Party (ReP)

The ReP usually embraces freedom of choice in personal matters, but tend to support significant government control of the economy. They generally support a government-funded safety net to help the disadvantaged, and advocate strict regulation of business. The ReP as a **Left Liberal** party tends to favor environmental regulations, defend civil liberties and free expression, support government action to promote equality, and tolerate diverse lifestyles.



Luckist Party (LP)

The Luckist support maximum liberty in both personal and economic matters. They revere Duchess Lucky as the once undisputed Queen of the "Ds". They also advocate a much smaller government; One that is limited to protecting individuals from oppression and violence. The Luckist as a **Libertarianism** party tends to embrace individual responsibility, oppose government bureaucracy and taxes, promote private charity, tolerate diverse lifestyles, support the free market, and defend civil liberties.



Tsarlack Democratic Party (TsDP)

The Tsarlack Democrats run a **Centrists** party that supports a middle ground regarding government control of the economy and personal behavior. Depending on the issue, they sometimes favor government intervention and sometimes support individual freedom of choice. The Tsarlack Democrats pride themselves on keeping an open mind, tend to oppose political extremes and emphasize what they describe as practical solutions to problems.





Tsarlack Government Party (TsGP)

The TsGP wants the State of Tsarlack to have a great deal of power over the economy and individual behavior. They frequently doubt whether economic liberty and individual freedom are practical options in today's world. The TsGP is a **Statist (Etatism)** party and tends to distrust the free market, support high taxes and centralize planning of the economy, oppose diverse lifestyles, and question the importance of civil liberties.



Tsarlack Socialist Movement (TsSM)

The TsSM has a socio-economic agenda in which property and the distribution of wealth are subject to **social** control. Its economic policy envisions a state or collective ownership of the means of production. This control, according to the TsSM, may be either direct, exercised through popular collectives such as workers' councils, or it may be indirect, exercised on behalf of the people by the state.





Tsarlack International Party (TsIP)

The TsIP is the Tsarlack **Communist** party, and its political ideology seeks to establish a future classless, stateless social Tsarlack based upon common ownership of the means of production.



Tsarlack Green Party (TsGr)

Tsarlack **Greens** generally support "grassroots democracy", pacifism, and social justice as naturally related to ecology and human bodily health. The Tsarlack Greens want to prevent global climate change, and preserve other aspects of the natural environment are viewed as necessary to maintain human life.





Tsarlack Party (TsP)

The Tsarlack Party promotes **Ultra-Tsarlianism** as a form of identity that holds ethnically and culturally united the Tsarlack islands. Tsarlianists believe that Tsarlianism is the fundamental units for Tsarlack's social life, and makes certain cultural and political claims based upon that belief; in particular, the claim that the Tsarlack nation is the only legitimate basis for the State of Tsarlack and the Kingdom of Tsarlack. Tsarlianists also refer to the specific ideologies of Tsarlianism, which make cultural and political claims on behalf of The Tsarlack Royalty.
